

**WILT Sunny 103.7
Pick Your Paradise
Official Rules**

NO PURCHASE NECESSARY. OPEN TO PERMANENT LEGAL U.S. RESIDENTS WHO ARE AT LEAST 21 YEARS OF AGE RESIDING IN NEW HANOVER, PENDER, BRUNSWICK, AND COLUMBUS COUNTIES. VOID WHERE PROHIBITED OR RESTRICTED BY LAW. ALL FEDERAL, STATE AND LOCAL REGULATIONS APPLY.

1. **HOW TO ENTER.** By entering, you agree to comply with all applicable laws and these Official Rules, and you agree to abide by all decisions of the Sponsors. The sweepstakes entry period begins on March 7, 2022 in the 6am hour and ends on April 1, 2022 in the 6pm hour. Only one (1) eligible entry may be made during the Promotion Period any additional entries received from any person will be voided.

There are two methods of entries for a total of One Hundred and Three (103) qualifiers.

How To Enter: Participants must listen for the Pick Your Paradise Sweepstakes sounder which will air up to five (5) times per day Monday through Friday between 6am and 6pm for a total of 20 weekdays. To qualify be the 7th caller by calling 910-790-1037 when you hear the cue to call. Calls to any other number will not be accepted. There will be a total of One Hundred (100) qualifiers chosen by this cue to call method. Three (3) Qualifiers will be chosen on the Sunrise Radio App through Sunny 103.7 by 5 PM on April 1, 2022. Participants entering by phone will be charged standard phone rates for calls according to the terms and conditions in their calling plan. Wireless services are not available in all areas. These methods run from March 7, 2022 at 6am through April 1, 2022 at 5 PM.
